


Determination of Procurement Method for Concession No. CRS-2024-01-06

The best interests of the Authority are served by awarding this new concession by:

- Bid
- Request for Proposal
- The Evaluation Committee may include non-Authority employees

The Board specifically determines that the best interests of the Authority are served by awarding CPA Concession No. CRS-2024-01, CPA Concession No. CRS-2024-02, CPA Concession No. CRS-2024-03, CPA Concession No. CRS-2024-04, CPA Concession No. CRS-2024-05, and CPA Concession No. CRS-2024-06 -via one request for proposal because each of these concessions have an identical scope—the non-exclusive privilege to provide motor vehicle rental services to the traveling public at the Francisco C. Ada/Saipan International Airport. Use of a single RFP in this situation will efficiently and effectively accomplish the intent of awarding these six concessions while saving the Authority the expense of time, money, and resources in conducting an RFP for each concession individually. A proposal submitted under this single RFP shall be considered a proposal for CPA Concession No. CRS-2024-01, CPA Concession No. CRS-2024-02, CPA Concession No. CRS-2024-03, CPA Concession No. CRS-2024-04, CPA Concession No. CRS-2024-05, and CPA Concession No. CRS-2024-06 and proposers shall be limited to one proposal submission. Award of these six concessions will utilize a single ranking of proposals generated from the RFP per NMIAC § 40-70-205(g)(3).¹ A ranked proposer selected for award by the Board per NMIAC § 40-70-205(h)(1) will not have its proposal considered to be the best proposal, in the opinion of the Authority, for any subsequent concession to be awarded under the RFP, making each ranked proposer eligible to receive only one of the six concessions. If awarded, one concession will be awarded before any award is made for a subsequent concession. In other words, CPA Concession No. CRS-2024-01 will be awarded before any award is made for CPA Concession No. CRS-2024-02, which will be awarded before any award is made for CPA Concession No. CRS-2024-03, which will be awarded before any award is made for CPA Concession No. CRS-2024-04, which will be awarded before any award is made for CPA Concession No. CRS-2024-05, which will be awarded before any award is made for CPA Concession No. CRS-2024-06.
