The Commonwealth Ports Authority (CPA) is soliciting statements of professional qualifications from interested Consultants for the Pagan Airstrip Airport Master Planning and Airports Geographic Information Systems (AGIS) Survey Services on the island of Pagan, Commonwealth of the Northern Mariana Islands.

It is recommended that qualification statements be presented by a combination of both brochures and the use of current U.S. Government Standard Form 330.
