Notice is hereby given that the Commonwealth Ports Authority (the "CPA") is accepting sealed bids, subject to the terms and conditions of the Invitation for Bid (the "IFB"), and other contract provisions, for bids from firms, companies, and/or corporations for Advertising Opportunities at the Tinian International Airport.

The IFB will be issued and available for pick-up beginning September 16, 2020, from 8:00 a.m. to 5:00 p.m., Monday to Thursday, at the Administration Office, 2<sup>nd</sup> Floor, Arrival Building, Saipan International Airport. CPA offices are closed every Friday for austerity reasons and also on holidays. The IFB includes layouts and requirements. All responses to this IFB shall also take into account any and/or all costs that will be charged to the bidder awarded the contract for the project. Prospective bidders will be required to pay an administrative fee of \$100.00 for costs associated with handling and consideration of the bid.




All bids shall be sealed and marked on the cover package outside as follows: "INVITATION FOR BID SUBMISSION: CONFIDENTIAL, ADVERTISING OPPORTUNITIES, COMMONWEALTH PORTS AUTHORITY CPA-IFB-003-20." One (1) original and two (2) copies of the bid must be submitted no later than 2:00 p.m. Chamorro Standard Time, October 20, 2020, to the Authority Administration Section, Office of the Executive Director, 2<sup>nd</sup> Floor, Arrival Building, Saipan International Airport.

Bids will be opened on October 20, 2020, at 3:00p.m. at the Conference Room, 2nd Floor, Departure Building, Saipan International Airport. Bids are not required to include a prepaid minimum concession fee. The concessions are for the right to advertise at certain designated locations within the Tinian International Airport for a period of two (2) years and requires the concessionaire to operate such concession to the satisfaction of the Commonwealth Ports Authority.

The Commonwealth Ports Authority reserves the right to reject any or all bids for any reason, if in its sole opinion to do so, would be in CPA's best interest. CPA further reserves the right to waive any defects in said bids if in its sole opinion to do so would be in CPA's best interest. All bids shall become property of the Commonwealth Ports Authority.
